XV. Approved Resolution D prepared by Thrun Law Firm with the Opt-In Subject to Rescission Related to the Allocation of Section 31aa Funding in Accordance with Michigan Public Act 15 of 2025.

Superintendent Katie Flynn explained approval of this resolution allows mobility to react to the legislation and related litigation while still providing an option to rescind. Final decisions are expected to be made and declared by December 30. While the funding impact to ISDs is minimal, there is a greater funding impact to local districts. ISDs and local districts are all acting on their own accords so whatever MAISD decides to do, it will not impact our local districts, their decisions, or their funding.


